What Aggies For Fresh Collects

Any personal information Aggies For Fresh may obtain about individual users to its website is information the user supplies voluntarily. Generally, you control the amount and type of information you provide to us when using our Website. As a visitor to our Website, you can browse our Website to find out more about us. This means that a user can visit the Aggies For Fresh website without telling Aggies For Fresh who they are or revealing any information about themselves. Cookies and Other Tracking Methods

Cookies are small pieces of information stored on a user's computer.
